SECTION A

BUILDING PERMITS ASCII FILES

Data tabulated by State, Metropolitan Area (MA), County, and individual permit-issuing places are available as ASCII, comma-delimited files. Data are shown for the number of buildings, number of housing units, and permit valuation within four sizes of residential buildings: (1) single family houses (attached and detached combined), (2) two-unit buildings, (3) three- and four-unit buildings, and (4) residential buildings with five or more units.

1. Data by State

The ASCII files show aggregated totals for each state. Totals are also shown for divisions, regions, and the United States.

2. Data by Metropolitan Areas

The ASCII files show aggregated totals for Core-Based Statistical Areas (CBSAs).

3. Data by Permit Issuing Places

ASCII files are available for entire regions. Data are included for the permit issuing places within the region, sorted by state and place. County and state totals are not included on these ASCII files. Monthly data are shown for the places that are requested to report monthly. Annual data are shown for all permit-issuing places in the region.

4. Monthly Cumulative Data

These files show all months of the calendar year for each permit office that is requested to report monthly (about 9,000). Prior months of the year are shown with the latest data available (late reports and corrections modify previous data). The annual file contains the latest monthly data for each permit office that is requested to report monthly. There is no annual data on this file.

5. County Total Data

The monthly files show county totals for all counties in which **every** permit office is requested to report monthly (about 900+). The annual file displays all counties.

- <u>Annual subscriptions</u> are available and include 12 consecutive months and one annual file, beginning no earlier than January of the current year or the next available month. All subscriptions include current month and year-to-date files, except *Monthly Cumulative Place level files*.

SECTION B

BUILDING PERMITS PRINTER FRIENDLY FILES

Data tabulated by <u>individual permit-issuing places</u> are available also as printer friendly files. Data are shown for the number of buildings, number of housing units, and permit valuation within four sizes of residential buildings: (1) single family houses (attached and detached combined), (2) two-unit buildings, (3) three- and four-unit buildings, and (4) residential buildings with five or more units.

Printer friendly files are available for the entire U.S. or individual states (subscription only). Data are shown for the permit-issuing places within each state, sorted by county and place. Monthly data are shown only for those places that are requested to report monthly. Therefore, the county and state totals may or may not reflect the total monthly activity within the area. Annual data are shown for all permit-issuing places in the state.

Printer friendly files of annual data are available from 2000 to present. Monthly data are available from January 2001 to present.

- Annual subscriptions are available and include 12 consecutive months and one annual file, beginning no earlier than January of the current year or the next available month.

SECTION C

SURVEY OF CONSTRUCTION (SOC) DATA

Estimates of Housing Starts Ratios

Estimates are available by month of start showing the proportion (ratio) of monthly permit authorizations started by permit authorization month. Each estimate is the ratio of the number of housing units authorized by building permits in the authorization month for which construction was started in the start month to the total number of housing units authorized by building permits in the authorization month.

Estimates for single-family and multifamily buildings are available by Census Region and Census Division. Estimates are from the Survey of Construction (SOC). Please refer to <u>http://www.census.gov/newresconst</u> for a full description of the SOC.

Data are available back to January 2011 (beginning with the March 2011 file) and can be purchased via annual subscription only, for \$180 per year.
