**NEW RESIDENTIAL CONSTRUCTION IN APRIL 2010**

The U.S. Census Bureau and the Department of Housing and Urban Development jointly announced the following new residential construction statistics for April 2010:

**BUILDING PERMITS**

Privately-owned housing units authorized by building permits in April were at a seasonally adjusted annual rate of 606,000. This is 11.5 percent ( $\pm 1.1\%$ ) below the revised March rate of 685,000, but is 15.9 percent ( $\pm 1.3\%$ ) above the revised April 2009 estimate of 523,000.

Single-family authorizations in April were at a rate of 484,000; this is 10.7 percent ( $\pm 1.1\%$ ) below the revised March figure of 542,000. Authorizations of units in buildings with five units or more were at a rate of 103,000 in April.

**HOUSING STARTS**

Privately-owned housing starts in April were at a seasonally adjusted annual rate of 672,000. This is 5.8 percent ( $\pm 13.0\%$ )\* above the revised March estimate of 635,000 and is 40.9 percent ( $\pm 19.8\%$ ) above the revised April 2009 rate of 477,000.

Single-family housing starts in April were at a rate of 593,000; this is 10.2 percent ( $\pm 10.7\%$ )\* above the revised March figure of 538,000. The April rate for units in buildings with five units or more was 68,000.

**HOUSING COMPLETIONS**

Privately-owned housing completions in April were at a seasonally adjusted annual rate of 769,000. This is 19.2 percent ( $\pm 13.8\%$ ) above the revised March estimate of 645,000, but is 8.7 percent ( $\pm 12.8\%$ )\* below the revised April 2009 rate of 842,000.

Single-family housing completions in April were at a rate of 564,000; this is 14.6 percent ( $\pm 13.1\%$ ) above the revised March figure of 492,000. The April rate for units in buildings with five units or more was 192,000.

**EXPLANATORY NOTES**

In interpreting changes in the statistics in this release, note that month-to-month changes in seasonally adjusted statistics often show movements which may be irregular. It may take 3 months to establish an underlying trend for building permit authorizations, 3 months for total starts, and 5 months for total completions. The statistics in this release are estimated from sample surveys and are subject to sampling variability as well as nonsampling error including bias and variance from response, nonreporting, and undercoverage. Estimated relative standard errors of the most recent data are shown in the tables. Whenever a statement such as "2.5 percent (  $\pm 3.2\%$ ) above" appears in the text, this indicates the range ( $-0.7$  to  $+5.7$  percent) in which the actual percent change is likely to have occurred. All ranges given for percent changes are 90-percent confidence intervals and account only for sampling variability. If a range does not contain zero, the change is statistically significant. If it does contain zero, the change is not statistically significant; that is, it is uncertain whether there was an increase or decrease. The same policies apply to the confidence intervals for percent changes shown in the tables. On average, the preliminary seasonally adjusted estimates of total building permits, housing starts and housing completions are revised about two percent or less. Explanations of confidence intervals and sampling variability can be found on our web site listed above.

*Unadjusted estimates of housing units authorized by building permits for January through December 2009 have been revised. Also, seasonally adjusted estimates of housing units authorized by building permits, started, under construction, and completed for January 2008 through March 2010 have been revised.*

\* 90% confidence interval includes zero. The Census Bureau does not have sufficient statistical evidence to conclude that the actual change is different from zero.
