Selected Statistics from the 2017 Economic Census of Island Areas

U. S. Virgin Islands

Did You Know

Establishments in the Finance and Insurance Sector (North American Industry Classification System code 52) reported average revenue per establishment of **\$9.5 million** in 2017

(Establishments in All Sectors (NAICS 00) had an average of \$2.4 million)

Establishments in the Finance and Insurance Sector reported average revenue per employee of **\$1,070,347** in 2017

(Establishments in All Sectors (NAICS 00) had an average of \$191,302)

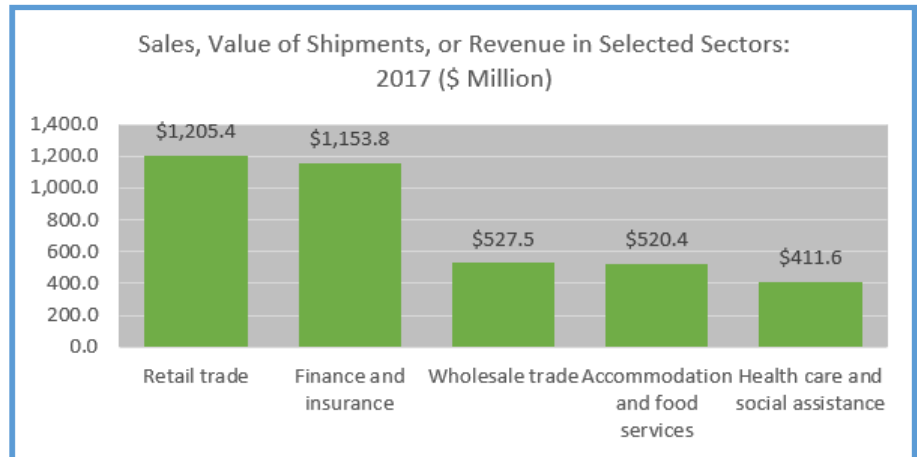
Workers in the Finance and Insurance Sector earned an average payroll per employee of **\$64,925** in 2017.

(Workers in All Sectors (NAICS 00) earned an average of \$33,373)

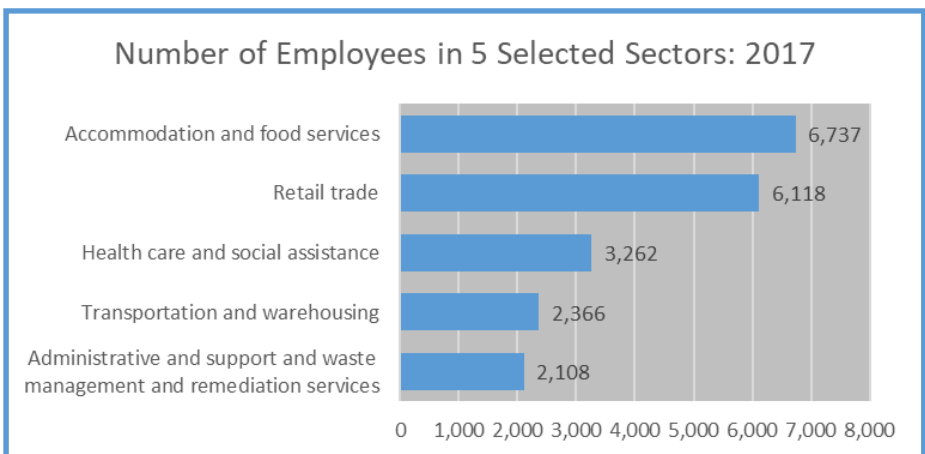
- ✓ Select Advanced Search

The **Economic Census of Island Areas** provides detailed data on Sales and other measures of business output for nearly every sector of the economy at the state-equivalent and local area levels by 2- through 5-digit North American Industry Classification System (NAICS) code.



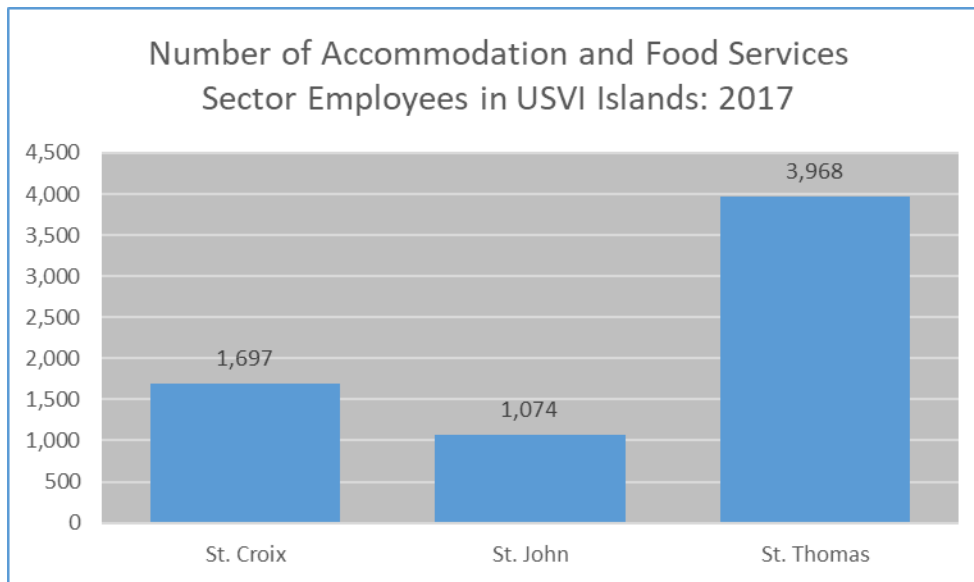
(Note: Excludes the Utilities Sector where revenue data was not available.)

Detailed data on employment and payroll are also available from the Economic Census of Island Areas.

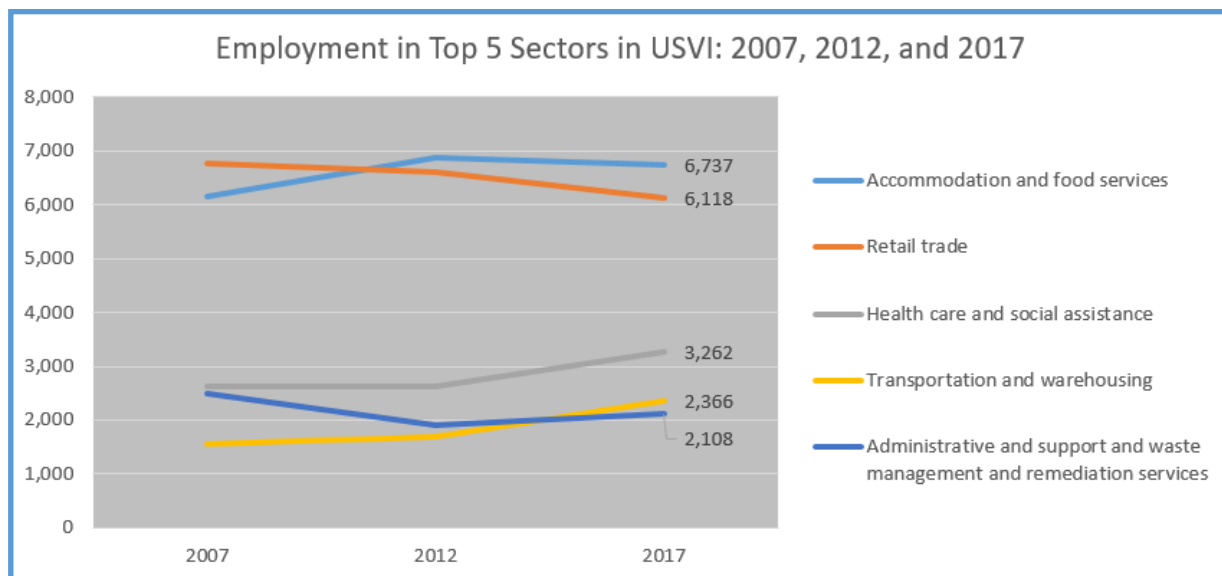


Detailed industry data from the **Economic Census of Island Areas** are not only shown for the U.S. Virgin Islands as a whole by 2–through 5-digit NAICS but also for each island (county-equivalent) and for selected cities (place-equivalents).

(Note: Data are often suppressed at the detailed 5-digit NAICS level for local areas to protect the privacy of individual businesses.)



The **Economic Census of Island Areas** is conducted every five years, for years ending in '2' and '7'.
