A Vital Resource for New Residential Sales Data

What does the New Residential Sales data provide?

The New Residential Sales economic indicator provides monthly estimates of new, privately owned houses sold and for sale at the national and regional level.

The U.S. Department of Housing and Urban Development (HUD) sponsors the collection of completion and sales data, as well as characteristics of new homes.



What data items are included?

- New single-family houses sold.
- The inventory of new houses for sale.
- Median and average prices of new homes sold.
- New homes sold and for sale by stage of construction (i.e., not started, under construction, or completed).

What geographic levels are provided?

Current-month estimates and revisions for previous months for new houses sold and for sale are provided at the national level and by census region. Average and median sales prices are provided at the national level.

Who uses the New Residential Sales statistics?

- The Bureau of Economic Analysis uses these data to estimate the nation's gross domestic product.
- HUD uses these data to assess their housing programs.
- The Federal Reserve Board and Council of Economic Advisers use the estimates to assess the condition of the economy.
- Trade and professional organizations use these data to analyze industry trends and benchmark their own statistical programs, develop forecasts, and evaluate regulatory requirements.
- The media use these data for news reports and background information.
- Private businesses use these data to measure market share, analyze business potential, and plan investments.
- Manufacturers use these estimates to plan production schedules and establish market shares. Insurance companies use estimates to adjust rates and establish replacement costs. Financial institutions use these data to estimate mortgage demand.

How frequently is New Residential Sales conducted and released?

New Residential Sales is conducted monthly. Data are available on or about the seventeenth working day following the reference month.


