Source Profiles - Goals

- Evaluate the quality and coverage of administrative records (AR) for decennial census purposes
- Provide information on individual AR sources compared to the 2010 Census
- Aid in decision-making about which sources could be used in a decennial context



Source Profiles - 2010 Census and AR Comparisons

- Number of addresses, persons, MAFIDs, PIKs, PIK-MAFID pairs
- 2010 Census and AR comparisons by select variables
 - Address
 - Person
 - Person at addresses
 - Demographic response information






Source Profiles

- National Change of Address file (NCOA)
- Indian Health Services Patient Registration file (IHS)
- Medicaid Statistical Information System (MSIS)
- Virginia and Oregon Supplemental Nutrition Assistance Program (VA SNAP, OR SNAP)
- Nevada Special Supplemental Nutrition Program for Women, Infants, and Children (NV WIC)





2010 Census and Administrative Records Address Match








Address Match

- NCOA covers a higher proportion of multiunit building, and coverage is highest in Military enumeration areas
- The highest proportion of OR SNAP MAFIDs that match to 2010 Census MAFIDs are Single Family Homes
- NV WIC covers a higher proportion of multiunit buildings (12-22 percent) with coverage of those with 2-4 units the highest





2010 Census and Administrative Records Person Match








Person Match

- Medicaid has better coverage of hard to count groups in the 2010 Census such as children, minorities, and renters compared to adults, non-Hispanic whites, and home owners
- IHS covers nearly half of all 2010 Census AIAN PIKs and provides lower coverage of the youngest and oldest age groups relative to those ages 5 to 64 years old
- Both VA SNAP and OR SNAP cover Hispanics, children, and renters better than non-Hispanics, adults, and owners



2010 Census and Administrative Records Person-Address Match







Demographic Response Match

- Age
 - Medicaid, IHS, VA SNAP have 95 percent or higher age response matches
 - OR SNAP 90 percent
 - NV WIC 89 percent or higher for all age groups except ages 5-17 (68 percent)
- For linked records with data on sex in both files, the response match rate is 98 percent or higher across all files

Nonresponse Follow-up Operations

 Many of these patterns are observed when linking AR to 2010 Census NRFU universe

 OR SNAP has higher coverage rates for NRFU compared to full Census for children, Hispanics, non-whites, women, and renters





Conclusions

- Administrative records may be able to assist with address and person coverage in decennial operations
- Address and person matches tend to be better than person-place matches
- Administrative records may be able to assist with determination of demographic response items
