

# U.S GOODS TRADE: IMPORTS AND EXPORTS BY RELATED-PARTIES, 2019

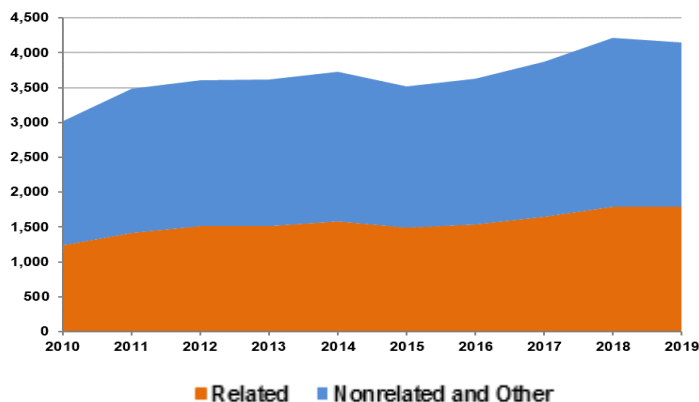
In 2019, the nation's international related-party trade accounted for 43.2 percent (\$1,790.0 billion) of total goods trade (\$4,145.0 billion). Related-party total goods is based on imports for consumption and total exports (domestic and foreign). Related-party trade includes trade by U.S. companies with their subsidiaries abroad as well as trade by U.S subsidiaries of foreign companies with their parent companies. Other trade is the estimate for shipments with a missing related-party status indicator.

- Related-party total goods trade is based on imports for consumption and total exports (domestic and foreign).
- Related-party trade accounted for 49.2 percent (\$1,230.5 billion) of imports for consumption (\$2,501.9 billion) and 34.0 percent (\$559.5 billion) of total exports (\$1,643.2 billion).
- In 2019, U.S. related-party trade decreased by 0.3 percent (\$5.1 billion) while total trade decreased by 1.7 percent (\$70.0 billion) from 2018.

## Related-Party & Total Trade (billions of dollars)



Related-party trade increased by 45.0% (\$555.9 billion) and total trade increased by 37.1% (\$1.12 trillion) from 2010 to 2019. In this same period, the value of related-party trade as a percent of all trade ranged between a low of 40.6% in 2011 to a high of 43.2% in 2019.

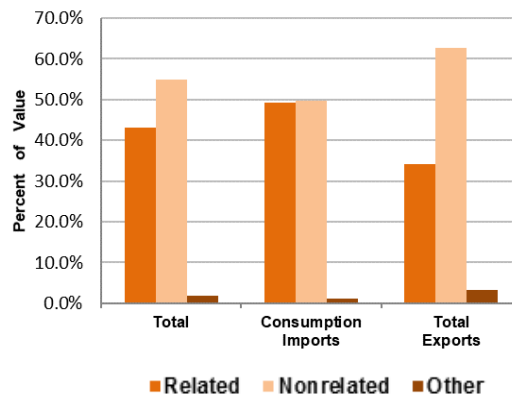

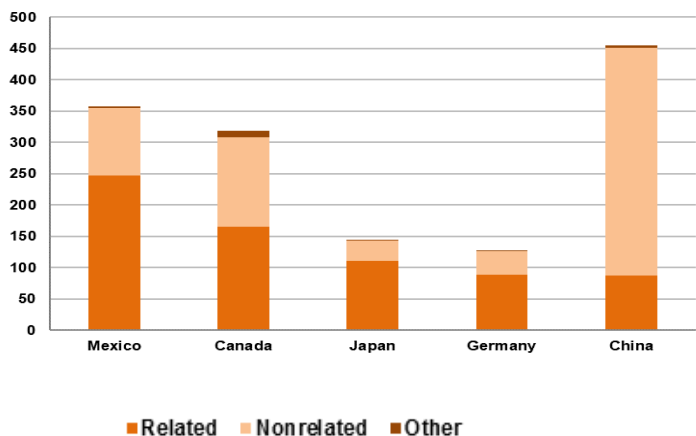

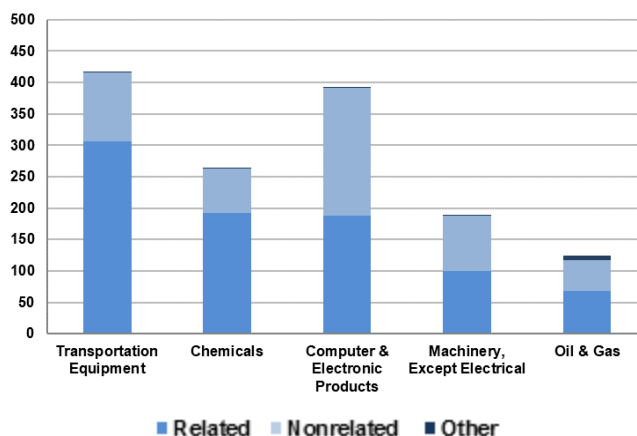

The figure above shows a snapshot of U.S. related-party imports from selected countries sorted by related-party value.

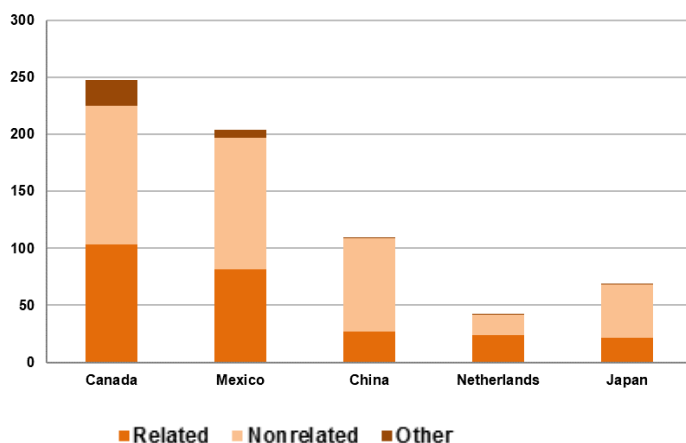
Top 5 Three-Digit NAICS Codes By Related-Party Trade

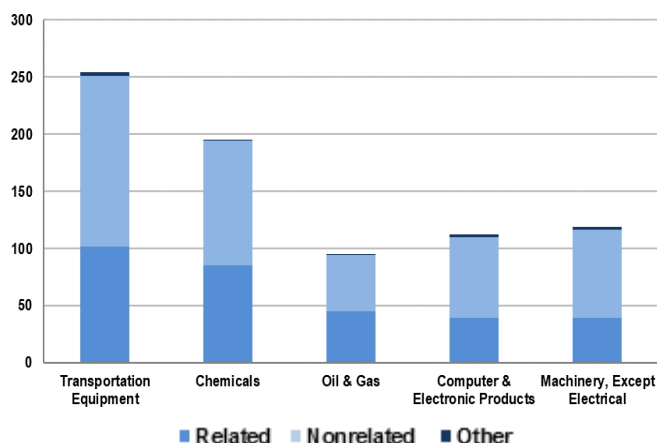
