Note 11.—Question No. 12 will only be asked in cases where an affirmative answer has been given either to question 10 or to question 11.
Note 12.—Question No. 14 will only be asked in cases where a gainful occupation has been reported in column 13.
Note 13.—In column 7 an abbreviation in the name of the month may be used, as Jan., Apr., Dec.
