




Census Count and the CCM Estimate (Level, in Millions)

Dual System Estimation Logistic Regression

- CCM using logistic regression instead of poststratification
- Haberman, Jiang and Spencer (1998), Griffin (2005), Mule and Olson (2005), Mule (2008)
- Logistic regression
- Include variables as main effects
- Do not need to include any unnecessary interactions
- Include more variables






National Components of the Census Count






National Components of the Census Count








National Components of the CCM Estimate




Percentage Net Undercount by Race Alone or in Combination and Hispanic Origin




Erroneous Enumerations by Race Alone or in Combination and Hispanic Origin






Whole-Person Census Imputations by Race Alone or in Combination and Hispanic Origin






Omissions by Race Alone or in Combination and Hispanic Origin






Percentage Net Undercount for American Indian and Alaskan Native Alone or in Combination by Geographic Area




Percentage Net Undercount for Persons by Type of Enumeration Area




Components of Census Coverage in 2010 by Type of Enumeration Area for Persons (Percentages)

Percentage Net Undercount for Occupied Housing Units by Type of Enumeration Area and Tenure








Percent Undercount by Bilingual Mailing Areas for Persons






Percent Undercount by Bilingual Mailing Areas by Hispanic Origin for Persons






Components of Census Coverage for Vacant Delete Check by NRFU Field Operation Status – Persons



Components of Census Coverage by CFU Overcount Question Household Status








Person Correct Enumeration Percentages for States, Counties, and Places






Person Erroneous Enumeration Percentages for States, Counties, and Places






Whole-Person Census Imputation Percentages for States, Counties, and Places





Person Omission Percentages for States, Counties, and Places




Percentage Net Undercount for Housing Units by Tenure 2000 – 2010




Percentage Undercount for Housing Units by Region in 2010
