

Summary of Changes

The Annual Revision Release on May 25, 2018 will include the following changes:

- Implementation of a new sample for the Advance Monthly Retail Trade Survey (MARTS) and the Monthly Retail Trade Survey (MRTS)
- Implementation of the 2012 North American Industry Classification System (NAICS)
- Discontinuation of the Collection/Publication of Leased Department Sales in NAICS 4521, Department Stores
- Updates to the Publication Table Layouts

New Sample

Monthly retail estimates will be published based on a new samples for MARTS and MRTS. New samples are introduced approximately every 2.5-3 years for MARTS and 5 years for MRTS. The introduction of a new sample enables us to incorporate the latest results of the Economic Census, implement classification changes, and redistribute the burden on the smaller companies. Details on the methods used to implement new samples will be included with the release in May.

2012 NAICS

This new sample will reflect 2012 NAICS and will implement updates based on classification changes. Below you will find a table of the 2012 NAICS definition changes for NAICS sectors 44, 45, and subsector 722. NAICS industries affected by the definition changes will be restated to the beginning of their time series.

Discontinuation of Leased Department Sales in NAICS 4521

With the implementation of the new samples, we will no longer be collecting data on the leased department sales within department stores. Thus, we will no longer publish estimates of Department Stores Excluding and Including Leased Departments. All estimates for department stores will exclude leased departments and will be published at the following levels: 4521 Department Stores, 452111 Department Stores (except Discount Department Stores), and 452112 Discount Department Stores.

Updates to Publication Tables

As a result of the implementation of 2012 NAICS and the removal of leased department sales, the publication tables associated with the MARTS and MRTS releases will be changing.
